



The text description for the above chart is as follows: The total revenue projected for Fall River Joint Unified School District is \$18,869,104, of which \$13,764,599 is Local Control Funding Formula (LCFF), \$1,861,534 is other state funds, \$847,962 is local funds, and \$2,395,009 is federal funds. Of the \$13,764,599 in LCFF Funds, \$1,518,977 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



In 2022-23, Fall River Joint Unified School District is projecting it will receive \$1,518,977 based on the enrollment of foster youth, English learner, and low-income students. The text description of the above chart is as follows: In 2021-22, Fall River Joint Unified School District's LCAP budgeted \$1,495,845 for planned actions to increase or improve services for high needs students. Fall River Joint Unified School District actually spent \$1,563,655 for actions to increase or improve services for high needs students in 2021-22.

The difference between the budgeted and actual expenditures of \$67,810 had the following impact on Fall River Joint Unified School District's ability to increase or improve services for high needs students:

To encourage student engagement to close the achievement gap, additional online curriculum resources were purchased for student use. Additional time was afforded to teachers to provide individual and small group tutoring.

FRJUSD strives to establish a culture of meaningful educational partner engagement across all of its programs. The primary emphasis of all engagement efforts is to develop, implement, and modify plans that are designed to drive school improvement. These efforts are highlighted through the development of the Local Control and Accountability Plan (LCAP) process. FRJUSD has engaged and continues to engage educational community partners throughout the 2021-22 school year. Additional funds that have been the subject of educational partner engagement that were not included in the development and approval of the 2021-22 LCAP include the additional COLA and the 15% increase to concentration funds. This engagement began in the fall of 2021 and will continue to involve certificated and classified staff, administration, and parents as plans continue to be monitored and revised based on local context and program needs. Other funds have been provided to FRJUSD that were not included in the 2021-22 LCAP. These funds include:

- Educator Effectiveness Block Grant
 - A-G Improvement Grant
 - Expanded Learning Opportunity Program

The development and implementation of these funds have also relied on FRJUSD's engagement efforts with educational community partners but it is important to note that each of these plans have their own independent planning and reporting requirements. As such, the review of 2022-23 Local Control Accountability Plan for Fall River Joint Unified School District Page 5 of 69 each of these funds will be not be included in the 2022-23 LCAP but will be reported and monitored independent of LCFF funding.

FRJUSD has 60.48% of students on Free/Reduced lunch. School sites with an enrollment of students who are low-income that is greater than 55% include 6 of the 8 school sites: Burney Elementary School, Burney Jr. Sr. High School, Fall River Community Day School, Fall River Elementary School, Mountain View High School and Soldier Mountain High School.

FRJUSD received \$1,569,496 in additional concentration grant add-on funding through the 2021 California Budget Act. We have used/plan to use these funds to:

Educational Technology Coach will engage and support digital transitions in the district. He will empower educators to use curriculum and instruction and provide them with personalized support in meeting their teaching needs. This service provides principals to support community learning hubs.

Providing a Special Projects Director to provide instruction and service to staff.

The district hired an academic counselor to provide academic services for pupils by providing information and assistance to parents and families on how they can effectively support students.

The district hired an academic/behavioral teacher to address learning loss by implementing evidence-based activities to meet the comprehensive needs of students.

The district increased the amount of instructional time by increasing nine teachers' time by one period to provide service based on students' learning needs.

Our LEA received the following one-time funds through the federal government to help us respond to the COVID-19 pandemic and the effects of distance learning on our students: CARES Act-Learning Loss Mitigation CARES Act-ESSER I/II CARES Act-GEER I/II

CRRSA Act-Expanded Learning Opportunity Grants ARP Act-ESSER III

Promotion of community engagement opportunities was conducted through the standard LEA communication channels, both internally to Fall River Joint Unified School District students, families, and community members. These channels included email correspondence, parent-teacher communication and public posting of meeting agendas. Fall River Joint Unified School District personnel engaged in meaningful consultation with families and staff members through surveys and in-person meetings. Additionally, parents are included in each meeting of the School Site Council at each of the 4 comprehensive sites. Fall River Joint Unified School District administration and program directors including special education administrators were consulted to identify needs, review funding sources, and develop plans for the various COVID relief funding sources (CARES Act, CRRSA Act, and ARP Act). The district also engages with the Native American community through Indian Education and IPC meetings, and with the English Learners community through ELAC meetings. In addition to these instances of specific outreach to the community members mandated by statute, the Fall River Joint Unified School District also provided opportunities for general public input at the regularly scheduled Board Meeting on October 13, 2021.

Our district received \$2,154,760 in federal ESSER III funds, and we delineated our plan for using these funds through our ESSER III Expenditure Plan, which was submitted to the Shasta County Office of Education for review.

The district plans to hire an Educational Technology Coach and purchase educational technology to ensure a 1:1 ratio of students: Chromebooks; purchase supplies to clean and sanitize busses and buildings, stipends for testing of staff and students; and the hiring of a Special Projects Director. Additionally, the district will employ an additional academic counselor to provide students' counseling, add an additional teacher, and increase instructional time by increasing the time of teachers by one period to provide services to students.

As of February 2022, we have experienced challenges in implementing many actions from our ESSER III Expenditure Plan due to staffing shortages. Vacant positions have made it difficult to realize the promise of federal relief funding. There are also sustainability concerns moving forward given that these federal relief funds are one-time dollars. The sub shortage that districts are experiencing across Shasta County has also made the delivery of much-needed professional development difficult. We have had to modify our plans to move things towards after school which prolongs the adoption and implementation window for trainings. Travel restrictions have also limited our ability to send staff to relevant professional development experiences. The extended time that we have had to fight against the COVID-19 pandemic has had a significant impact on the social and emotional well-being of our students, their families, and our staff. Effects of quarantine and isolation of students and staff have poses significant disruptions to school programs throughout the year and the mitigation efforts (testing, contact tracing, etc.) has meant that less time is spent on the implementation and monitoring of the overall instructional program.

The 2021-22 school year has been a year of many plans, and our LEA has worked diligently to ensure that all plans are aligned and all funds can be maximized to support student outcomes. As noted throughout this document, our district has received one-time state and federal funds that are geared toward keeping our schools safely open while preventing the spread of COVID-19 and accelerating student learning recovery after a year spent in distance learning.

To that end, we have worked to align our fiscal resources to our 2021-22 LCAP in the following plans in these ways:

Safe Return to In-Person Instruction and Continuity of Services Plan- By creating a plan that protects students from COVID and in school for in-person instruction, students will have the opportunity to complete A-G courses, maintain participation in AP courses. be engaged in their learning, and maintain opportunities for parent input.

ESSER III Expenditure Plan- This plan includes an additional academic counselor, extra instructional periods, and technological resources that will help students attain their goal to graduate college or career ready.

Plan Summary [2022-23]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

The Fall River Joint Unified School District serves approximately 1,193 students who come from a large geographic area, covering over 1300 square miles. The district features 8 schools, with the majority attending one of our four comprehensive schools: Burney Elementary, Burney Jr-Sr High School, Fall River Elementary, or Fall River Jr-Sr High School. The district also includes two continuation high schools, Mt. View and Soldier Mt.; Fall River Community Day; and the Mount Burney Special Education Center which serves students with moderate to severe disabilities. Most of our students are transported to school by bus. At the eastern edge of the district are the agricultural communities of Fall River Mills and McArthur. In Burney, the local economy used to revolve around the lumber industry; however, today there are fewer families tied to this. Major employers in the area stem from two remaining lumber mills and agriculture, and numerous indirect employees: a local hospital and additional care centers, PG & E, a major construction company, and our school district. Recent data shows that 60.9% of students qualify for the free or reduced lunch program, and the Unduplicated count is 62%. The district's student ethnicity is white (60%), Hispanic (26%), and American Indian (7%). Major subgroups include English Learners (8%) and students with disabilities (18%).

The district has a Special Education program and the Mt. Burney Center that serve students with mild to severe physical, academic, behavioral, and emotional needs.

All students are issued a Chromebook which has allowed the district to continue with 1:1 technology. Chromebooks are allowed to leave the high school sites but must remain at the elementary school sites.

District students are provided a solid education with college preparedness, CTE Pathways, and a variety of electives to help students graduate as college and career ready.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

The LEA is very proud of the number of accomplishments we have achieved through the LCAP process. One area of importance is technology. All students in grades 7-12 are loaned their own Chromebook to use at school and at home, and the student and parent surveys indicate 86% of "agree/strongly agree" that students have internet access at home. Additionally, Chromebooks or other devices are provided to all students in our elementary sites, although those devices are to remain at school. While this has proven to be valuable to all students, those who are unduplicated (low-income, English learners, or foster youth) now find themselves with equal opportunities in accessing resources to enhance their education. Technology has also provided additional curricular areas, including Odysseyware, an online curriculum utilized throughout our alternative education programs, provides summer school credit recovery and offers remediation opportunities. It is also used in the Long Term Independent Study program. Professional development opportunities, most funded through the LCAP, have helped prepare teachers to meet these new technological advancements.

Data is being used to improve attendance rates throughout the LEA; however, there is an ongoing concern with chronic absences. There are additional efforts to improve attendance provided by our district's "behavior coaches" who work at our elementary sites. They, in addition to our secondary school counselor, have worked with families to insure students regularly attend school. The presence of these three employees has also decreased our LEA's overall suspension rate by 7.2% and during the last three years, the LEA has had less than 1% of student expulsions.

Graduation rates for the students in the LEA have increased over the last several years, though we do not yet have the 2021-2022 data (98% for the 2020-2021 school year, 95.5% for the 2019-2020 school year, 93.43% for the 2018-19 school year, 98.34% for the 2017-18 school year).

Through the LCAP, we have also added two paraprofessionals to assist our Native American students with attendance and academic progress. This has narrowed the learning gap between Native American students and our largest subgroup, the White students. Based on recent Summative ELPAC scores (2020-2021), 14.29% of students scored proficient.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

The 2020-2021 CAASPP scores revealed that, even though the district offered in-person instruction for the entire 2020-2021 year, students' performances decreased in slightly in ELA and more noticeably in Math. Pre-pandemic, Math scores had been improving. (There are no scores from 2019-2020.) Student scoring "met" or "exceeded" in ELA: 2016-17 43%, 2017-2018 37%, 2018-2019 37% and 2020-2021 35%. Student scoring "met" or "exceeded" in Math: 2016-17 30%, 2017-2018 35%, 2018-2019 37% and 2020-2021 28%. The district was also not able to offer Advanced Placement courses to students like it had pre-COVID. Schools have adopted intervention resources, such as Read180, Lexia, Renaissance, Literacy and Language, and Flex. Additionally, district chose a two new online programs, Edgenuity and Courseware, for Independent Study, the alternative education schools, summer school at both comprehensive school sites, and any needed credit recovery.

The COVID pandemic continues to impact student attendance. FRJUSD was open from 2020-2021 when 95% of California schools were still closed, and of course, was fully operational, including Independent Study, during the 2021-2022 school year. COVID 19 illness and quarantine led to a 35% absence rate last year (2020-2021), which dropped to 22% for the 2021-2022 year. To address Chronic Absenteeism, the LEA has joined the SCOE SARB program. The staff has regularly participated in Professional Development offered through the Shasta County Office of Education (SCOE) to develop differentiated assistance and increase classroom engagement. A review of teaching and scheduling strategies is being implemented to hopefully improve student engagement, and therefore attendance. Communication efforts between the school and home are being developed. Schools are having in person and phone conferences with parents and students to determine reasons for absenteeism and encourage attendance. Students in extra-curricular activities are not allowed to participate in activities if they are not in school for the entire day. Based on data, specific groups of students have been targeted to see if new strategies will improve attendance. Native students with poor attendance are being addressed, sometimes resulting in-home visits. Culturally relevant units of study focused on local Native Tribes have been developed with SCOE, and cultural celebrations recognized. If students are missing school because of suspensions, schools are using alternate means of correction, such as restorative justice, to keep the students in school.

The strain and stress of providing instruction during the COVID pandemic have caused the work of monitoring and supporting the mental health and social/emotional well-being of students and staff to become the district's top priorities. Based on input from our educational partners, student well-being and mental health were their number 1 priorities. To respond to this need and do this work, the district has been forced to address several challenges. One challenge has been the need to provide professional development and learning opportunities for staff to build their capacity to support the SEL work. While the district had done some SEL work pre-COVID, it was not adequate to the level needed to meet current demands. The district used staff collaboration time to provide SEL training, specifically teaching staff CASEL's core competencies and the development of SEL-informed lesson planning that regularly included best practices from research-based resources like CASEL's Signature Practices Playbook and The Distance Learning Playbook. The district received support from outside expertise, including the Shasta County Office of Education in their regular training and administrative resources aligned to the SEL needs of districts. In addition to the challenge of capacity, there has been the challenge of resources. To help with this, early in the pandemic our school

counselor in the district had the opportunity to connect with a county-wide collaborative. Facilitated by the Shasta County Office of Education, this collaborative provided a forum for counselors to meet on a monthly basis. Support for SEL work was a standing agenda item in each meeting. In addition, the Shasta County of Education established an SEL Community of Practice opportunity for our district to participate in monthly meetings with other districts from across the county. This Community of Practice works in conjunction with other counties statewide to learn and build SEL capacity by collaborating around statewide best practices, exploring curriculum resources and modules, and sharing needs and challenges. As a result of participation in the county's Community of Practice, the district will be able to access and implement a much-needed Tier 1-3 web-based curriculum (BASE Education) for our secondary (6-12 grades) students over the next two years. Other resources that have been made available to the district through various sources include free suicide prevention training and pilot access to Kelvin. Kelvin is a formative assessment tool that allows the district to conduct regular "pulse" survey check-ins with students in an embedded interface on every district Chromebooks device. Self-care strategies and resources have also been regularly shared and discussed in collaboration meetings in an effort to ensure that staff are intentional about maintaining their own mental health and social and emotional well-being throughout the prolonged pandemic.

LCAP Highlights

A brief overview of the LCAP, including any key features that should be emphasized.

The process for gathering information for this year's LCAP featured a very concerted effort to insure all educational partners had ample opportunity to share concerns about current LCAP plans and expenditures.

The general feeling is that the district is continuing to meet our first LCAP goal--ensuring all students are graduating with the necessary skills to prepare them for a college education and/or a career. We are monitoring and showing some growth in the progress our EL students are making in our district's second goal, though EL progress remains a concern. Educational partners recognized and support the district's dedication to maintaining 1:1 students to technology access; and parents indicated an appreciation of being able to access the schools, events, and celebrations after having to isolate last year. Other concerns, after looking at data, included a slight decrease in the area of English Language Arts and a more marked decrease (9 % points) in math.

The district efforts were recognized for having more staff and resources available to students, and more intervention opportunities. The certificated staff numbers increased to eliminate some elementary combinations classes, and high school preparation periods were bought back to provide small group and individual tutoring; the paraprofessional staff increased in EL, behavior coaching, and special education; and a variety of resources were purchased to increase and improve intervention and engagement efforts. Educational partners are looking forward to the increase in counselors district-wide, who will be available at all school sites for academic and SEL counseling. They are also looking forward to having a full-time nurse fully available again next year.

Mt. View Continuation High School receives ample support in developing comprehensive support and improvement plans. For years, the superintendent was also principal of Mt. View. Starting the 2021-2022 school year, the superintendent designated a principal for the alt ed sites, including Mt. View. That principal has met regularly with the staff of Mt. View to assess program needs. From that needs assessment process, it was determined that the LEA needs to offer coaching and resources. Through the WASC process (Mid-Term visit) new supports were identified such as employment of a career tech counselor, intern opportunities, and a vetting of a new online resource for standards based core courses and electives, Courseware, that will increase student engagement.

Monitoring and Evaluating Effectiveness

A description of how the LEA will monitor and evaluate the plan to support student and school improvement.

Data around high school graduation metrics, distance learning progress, and student conduct data has been analyzed with direct resource being distributed at the site. Graduation data reveals that students have entered the program with deficient credits, made up said credits, and are moving forward with a high school diploma. Mt. View continues to have a high graduation rate.

Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

The general feeling was that if the stakeholders were not "coming to the LCAP team, the team would go to them." In addition to regular updates at each monthly school board meeting, there was an ongoing effort to provide additional opportunities for stakeholder engagement this year. Relevant data, referring to both state and local indicators, was gathered and shared at each monthly board meeting by the superintendent with input from site administrators. This data was also available on our district's web page. Other than the surveys, all consultations were in an organized meeting format, complete with Agendas and minutes. A "four square" for inviting input on what to keep, what to stop, what to start, and what to tweak was provided at meetings, Partners were encouraged to provide feedback.

The student, parent, and staff survey was made available in May. It was a struggle to get participants; many invitations to participate were communicated to educational partners. The district received 274 student responses, 60 parent responses, and 71 staff responses. Student and parent participation dropped in 2022 compared to 2021 and increased for staff. Additionally, the two elementary schools and the three alternative education sites participated in Kelvin surveys 5 times throughout the school year to assess current social-emotional concerns and celebrations.

A summary of the feedback provided by specific educational partners.

The numerous LCAP meetings held this year helped validate current LCAP plans and expenditures as well as provide suggestions, based on current data, for potential changes and/or additions to the 2022-23 LCAP. Decisions at the meeting were data-driven and related to state or local indicators.

Areas that were consistently addressed included how many students are struggling with abnormally deviant behaviors, specifically self-regulation. This concern was voiced by certificated staff at Site Council meetings.

Additionally, school staff remains concerned about student attendance for the general population and subgroups. Parent partners at the Site Council meeting were pleased to hear the district is again employing SARB to support attendance. Attendance and tardy were concerns in the student surveys.

EL students are making adequate progress, but teachers voiced concern that EL students were frequently pulled out of core instruction to receive EL services. Both student and parent surveys had concerns that EL students were not getting enough academic support.

In the area of Equity, the district and school administration noted that Students with Disabilities and American Indian students have higher suspension rates than the general student population.

Staff and parents requested more Special Education staff to meet student needs. Another concern voiced by teachers and parents at the Site Council meetings was how many days the district had to ask the Special Education or Title 1 teacher to cover a general education classroom. There is also a para that is able to substitute and she was regularly removed from her paraprofessional position to cover for the teaching staff.

Ongoing Professional Development, particularly in the area of technology and working with students in trauma, remains a priority according to staff.

404 surveys were completed.

The student surveys revealed: adequate access to technology improved, EL students get the help needed at school declined from 58% to 45%, absences/tardies as major problems increased from 34% to 43%, feeling safe at school declined 5 percentage points from 62 to 57, students being bullied increase from 33% to 41%, opportunity to take A-G courses declined from 61% to 53%.

Parent surveys revealed: District succeeded in attracting talented professionals declined from 55% to 35%, opportunities for parent involvement increased from 50% to 76%, counselor has been helpful decreased from 20% to 14%, EL students have adequate academic support declined from 36% agreeing to 19%, district providing adequate interventions decreased from 54% to 39%, and satisfaction with student's academic growth plummeted from 82% to 55% with 29% of parents now disagreeing/strongly disagreeing, if child feels sate at school dropped from 72% to 62%, and students/parents understanding the importance of regular school attendance dropped from 84% to 77%, and students have the availability to take classes needed to graduate and attend university increased in the disagree/strongly disagree from 8% to 18%.

Staff surveys revealed: adequate teacher collaboration time dropped from 63% to 50%, feeling safe at school dropped from 90% to 76%, students feeling safe dropped from 86% to 64%, students are well-behaved declined from 50% to 29% BUT spending too much disciplining dropped in the disagree/strongly disagree from 31% to 15%, looking forward to coming to work increased in the disagree/strongly disagree from 9.6% to 17%, parents respect teachers dropped from 67% to 46% and students respect teacher dropped from 65% to 37%, the school consistently reinforces discipline dropped from 62% to 48%.

The Board agreed with LCAP goals and was supportive of the LCAP progress.

This LCAP Metric Chart was regularly shared with all stakeholder groups. Additional data was presented as needed. The leadership team reviewed LCAP Data Metric Chart noting the various areas where goals were not met.

Teachers of students in grades 5-12 supervised students completing the online student survey. Parent survey participation increased by 8.5% overall; 51 employees completed the staff survey

The LCAP was reviewed at the June 8, 2022 board meeting and approved at the June 22nd meeting

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

Educational partner involvement has resulted in improved outcomes and opportunities for all pupils, including unduplicated students, throughout the process. All meetings were directed at the needs of all students with our LEA's unduplicated students receiving additional consideration for increased or improved services. Stakeholder engagement/feedback led to the development of the LCAP and Annual Review, including the Impact on the LCAP, Goals, Actions, and Services.

Expenditures specifically resulted in increasing the daily amount of time allotted to the Behavior Coach plus an additional behavior paraprofessional in Special Education for students with exceptional needs. Behavior paraprofessionals who work in our elementary schools remain in place to assist with students who suffer from mental issues, such as trauma or disruptive behaviors, not only to serve those students but other students who may be distracted by such behaviors.

The district has added another PPS counselor so that there is now a counselor at each end of the district to serve the comprehensive high school, elementary school, and continuation high school. Each high school now has a principal, a dean of students, and share the counselor. They are able to support students with mental health issues and academic struggles.

There was also concern from stakeholders that our EL students were in need of additional support. This resulted in adding a .5 FTE EL teaching position to the LEA. Two online resources were purchased to support EL learners.

Stakeholders also emphasized the need to continue providing district transportation as unduplicated students would have difficulty getting to school on their own.

Much discussion also centered on the effects Covid-19 had on the District and how students who have fallen behind were supported in the 2021-2022 academic year but would require continued support in 2022-23 to close the academic gaps created due to the pandemic and the chronic absenteeism.

Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

Year 1 (2021-2022)

The first goal, all students graduating career and/or college-ready, is challenged by chronic absenteeism, the COVID learning gap, and negative behaviors, all results of the last two years of pandemic schooling. The district chose to increase staffing for both certificated staff and paraprofessionals to meet the needs for improved classroom engagement to address attendance, poor behavior, and the COVID learning gap. The hours of the behavior coaches were increased to meet SEL and behavior concerns. The Native American paraprofessional hours (1.8) decreased because the district was not able to fill the Indian Education paraprofessional positions until partially through the year. The behavior coach paraprofessional (1.9) hours increased by more than \$1,700 to meet the needs of students struggling with poor behaviors that impacted the learning of the individuals and the students around them. Professional Development dropped considerably due to the lack of opportunity for PD because of COVID restrictions. Web-based resources (1.11) and technology (1.14) increased from \$10,466 to \$57,924 and \$14,300 to 433,673 as resources were needed to support the increase of students learning online or needing online interventions to mitigate learning loss. COVID impacted Advanced Placement participation (1.12) as staff was unable to offer courses because students were struggling with COVID quarantines or illness. Provide and maintain Special Education funding (1.15) increased by more than \$14,000 dollars as more paraprofessionals were added to address student academic and SEL needs. Food Services support (1.16) decreased by more than \$20,000, probably because of students' chronic absences.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Increased staffing support will enable unduplicated pupils, those with exceptional needs and significant subgroups to receive more small group or individualized services: additional behavior coaching time, additional paraprofessional hours, additional certificated staff to support smaller class sizes with no combination classes in the elementary schools. The amount expended for the Native American paraprofessional dropped slightly. Due to a lack of applications to fill a para position at a high school, a current para who was working at the elementary school for five hours added the high school to her schedule, cutting the elementary school to 3.5 hrs per day with 3.5 hrs at the high school. However, more money was expended on behavior paraprofessionals within Special Education to help students cope with dysregulation. There is a significant increase in the amount spent on web-based resources and technology as many of our students spent more time online due to COVID illness or quarantine. As a concern, again because of COVID, AP classes were not offered so there is a significant drop in that action. For our ELD population, more money was expended on personnel and instructional materials to meet their needs. There is now a full-time certificated teacher and two 6 hr paras working with ELs. The online resources for EL students now include Read 180 and Imagine Learning Language to Literacy.

An explanation of how effective the specific actions were in making progress toward the goal.

Students continue to struggle with academics, behavior, and attendance. The pandemic created learning gaps; students are struggling with mental health; and many families lost their focus on daily attendance. We've seen significant progress towards this goal due to improved

attendance because of spending more money on personnel. Students were able to receive immediate feedback to an academic issue. They had more staff to connect to when mental health issues arose. There were more people checking on their attendance and verifying absences and needs with families. We do not have data on how our academics were impacted.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

The metric and desired outcome for the suspension indicator was changed to include Native American and Special Ed Suspension rates. Both of these were mentioned in Education Partner meetings. Actions 1.8 and 1.15 both contribute by using Title VI Indian Education and Federal and State Special Education funding.

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Year 1 (2021-2022)The certificated and paraprofessional staff were increased to offer appropriate support to EL students. Staff was provided with professional development opportunities. Additional resources were provided, including Instructional technology and related materials for EL students.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

For the ELD population, more money was expended on personnel and instructional materials to meet their needs. There is now a full-time certificated teacher and two 6 hr paras working with EL students. The online resources for EL students now include Read 180 and Imagine Learning Language and Literacy. Read 180 is supporting seventh-twelfth grade students in ELA. Language and Literacy supports Kindergarten through sixth grade in ELA. There is a significant increase in the amount spent on web-based resources and technology as many of our students spent more time online due to COVID illness or quarantine. There was a significant drop in expenditures for professional development as COVID 19 limited offerings and group professional development.

An explanation of how effective the specific actions were in making progress toward the goal.

Due to the pandemic, students continue to struggle with academics, behavior, and attendance. The academic gaps are noticeable, students suffer from mental health issues, and families are not as focused on daily attendance. At this time, we do not have updated Summative ELPAC score reports for 2021-22. Additionally, since the resources were new this year (ELA programs), we do not have data to compare.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Changes were made to the planned goal because the original goal was not measurable with data. We also change the second metric to Summative ELPAC for clarity. We will eliminate metric five as it is redundant with number two. We changed desired outcomes for #1 for clarity, #2 -6 because numbers are based on current data. We did not change any actions.

In our engagement with stakeholders, there was consensus around the unique needs of our foster youth, English learners, and low-income students. Specifically, the development of our LCAP focused on these particular needs:

*These students need high interest and engaging instructional materials and content

*The district's instructional delivery model needs to be changed to provide more instructional focus in elementary grade levels

*Our foster youth, English learners, and low-income students clearly need more instructional time to develop academic proficiency

*These specific student groups showed evidence that there was a need for more social-emotional learning/well-being support

To meet these unique needs the district will be providing these actions to increase and improve services:

* Teacher position added to eliminate combination class (grade level integrity for EL, Foster Youth).

* New science materials adopted in 2020-2021 with Professional Development for the 2022-2023 school year.

* EL Paraprofessionals increased 7 hours in District (100% increase).

* Multiple new paraprofessional hours added to provide more support to Indian Education, Special Education, and English Learners.

* Internet and software applications to improve communication and promote an increase in parent involvement/participation in district decision-making

* Provide and maintain highly qualified teachers and paraprofessionals for alternative education students

* Provide professional development designed to meet the specific needs of foster youth, English learners, and low-income students, including Social and Emotional Learning, Mental Health, and instructional strategies

* Maintain support for student basic needs including home to school transportation and food services

* Increase specifically designed supports for students with disabilities and Native American students district-wide

* Increase access to relevant instructional technology tools and applications and rigorous academic programs like Advanced Placement courses

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

Using the district's supplemental and concentration funding, the district will be able to increase instructional time with the elimination of the combination classes and providing elementary summer school. Additional support will come from increased paraprofessional hours (including EL paraprofessional support) Goal 1 Actions 1.6, 1.7, 1.8, 1.9, 1.15; increased intensive instructional support from the teachers (in place of their preparation periods), and the full-time counselor position. Improved services include the new science materials Goal 1 Actions 1.10, 1.11, 1.12, 1.14, mental health referral program, and teletherapy Goal 1 Action 1.14.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Using the district's supplemental and concentration funding, the district increased instructional time with the addition of two certificated positions and the elimination of the combination classes. Additional support will come from increased paraprofessional hours, including EL paraprofessional support and behavior coaches, increased intensive instructional support from the teachers individually or in small groups (in place of teacher preparation periods), and the full-time counselor position. Improved services include the new science materials, mental health referral program, and teletherapy.
