For a variety of reasons, not all students are successful in a traditional high school setting. If the student has no motivation or academic goals at all, they will not succeed regardless of the structure of the program.

The mission of our Community Day Schools is to meet the California Department of Education regulation 48916.1 (a) "At the time an expulsion of a pupil is ordered, the governing board of the school district shall ensure that an education program is provided to the pupil who is subject to the expulsion order for the period of the expulsion", the Fall River Joint Unified School District established the Community Day School Program. This program provides students the opportunity to earn readmission to the regular program at the end of the required term and to prepare those who do not qualify for readmission for the next steps in their educational career.

School Safety Plan (School Year 2011-12)

Burney Community Day has a Comprehensive Safety and Response Plan which meets the state requirements described in California Education Code Sections 35294-35297. The plan was developed in cooperation with the Shasta County Sheriff's Department and has conducted school wide drills in order to better prepare in the event of an actual emergency. This plan includes disaster procedures, procedures for safe entry and exit of students, procedures for serious disciplinary problems, a sexual harassment policy, child abuse reporting procedures and school discipline policies. The plan is reviewed annually at the start of school in order to ensure that new staff is familiar with all details.

School Facility Conditions and Planned Improvements (School Year 2012-13)

The district takes great efforts to ensure that all schools are clean, safe, and functional. Mt. View Continuation High School, Burney Community Day, and the Elementary Community Day are housed in the same building as the District Office, which is over 50 years old.

During the 2004-05 school year, a local bond measure (Measure J) was passed by the community authorizing 4.4 million, which was combined with 6.6 million from the state for modernization. The money was used to replace the roof on the Mt. View/District Office facility. The work on this project was completed during the summer of 2005.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified
 achievement standards in ELA for grades three through eleven; mathematics for grades three
 through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in
 grade ten. The CMA is designed to assess those students whose disabilities preclude them from
 achieving grade-level proficiency on an assessment of the California content standards with or
 without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in
 grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to
 those students with significant cognitive disabilities whose disabilities prevent them from taking
 either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.
